The Iglesia de Cristo continues to enjoy considerable growth and progress. This quarter there has been one additional baptism, Magally Basilio. This brings to 63 the ones who have been baptized since the work began just a little over three years ago.

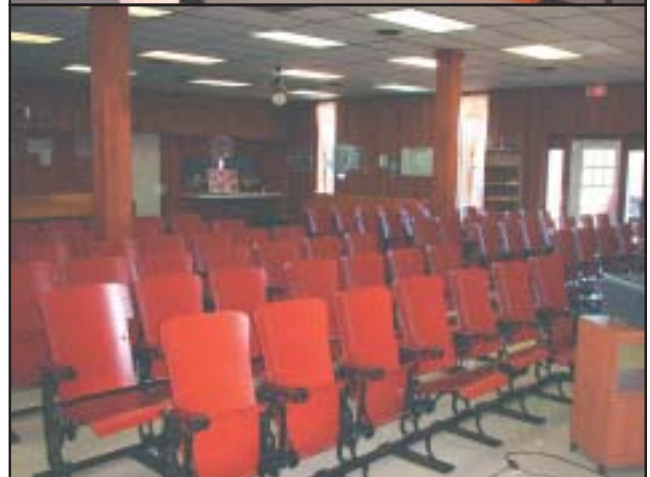
A major event for the congregation is the installation of a baptistery. The total cost of this will be approximately \$5,000-\$6,000. A little over \$2,000 has been received to help pay for this. Thanks to all who have contributed toward this.

There also remains an outstanding debt on the building. At this writing the balance is \$106,286.20. Likewise, thanks to all who have

donated to help reduce this amount. Those who would be willing to further help pay this note off either by monthly or "one time" gifts are asked to send their contributions to the Hispanic Fund at the Church of Christ at Bybee Branch.

We express thanks to the Summitville contribution for the donation of several oak pews and to brother Stanley Graves for arranging the donation of about 80 theater type seats. These have been of great help.

Finally, the Iglesia de Cristo will have a Gospel Meeting with brother David Esparza of Houston, TX on April 25-27. They are expecting about 150 at each service. Please pray for the success of this meeting.
